- Annual Passes are not transferable.
- Annual Passes are valid one year from the date of purchase.
- Annual Passes must be paid in full at the time of purchase.

- Annual Pass fees are non-refundable. In the event of a medical emergency or relocation out of the area, exceptions may be made by the GM.
- Acts of God or other developments out of the control of Troon Management or the City of Cape Coral will not constitute a pro-rated or full refund.
- All annual pass holders are required to register in the Golf Shop prior to teeing off.
- As Coral Oaks Golf Course is a daily-fee course, there will be dates in which tournament groups will take up the course. In this regard, there will be some dates where tee times will not be available to annual pass holders.
- Junior add on pass holders must be 17 years of age or under and live in the same household. If they do not have a valid driver's license, they may not use a cart. Must play 9 holes before 8am or after 1pm.
- 9 Month Paly passes are valid from April thru December and receive 20% off published daily rates. January thru March.

- In accordance with State and Local Laws, outside alcohol may not be brought on, nor consumed on, the premise, including the parking lot. Any such items that are found will be confiscated and may result in the immediate termination of the annual pass.
- Coral Oaks Golf Course represents and warrants that it follows all applicable Federal, State, and Local Laws, Ordinances, and Executive Orders. As such, all patrons are expected to comply and follow such regulations. Any instance of willful and/or repeated disregard for such regulations, and/or other socially unacceptable behavior, may result in the immediate termination of the annual pass without refund of payment and permanent ban from the facility.
